**Kirkland Lake, Ontario.** GLR Resources Inc. "GLR" and RJK Explorations Ltd. "RJK" have completed drilling on their 100% owned 13,000 acre base metal property located in Aldina, Marks, Sackville and Adrian Townships 65 kilometres west of Thunder Bay, Ontario. Three areas tested by 826 metres of diamond drilling included an untested 700 metre long area westward extension of the mineralized felsic (rhyolite) horizon; a felsic horizon 2 kilometres to the north; and an induced polarization trend between these:

Core lengths sent for assaying are estimated to be approximately true widths.

With the completion of this drilling, the main felsic unit has been extensively tested at shallow depths. In spite of the low amount of mineralization in the western extension, well-defined alteration patterns have provided new insights on the more complex main showing area. Additional deep drilling may be warranted with a renewed evaluation of the main showing. All samples were sent to be analysed by Accurassay Laboratories located in Thunder Bay, Ontario.
